CMC

CMC is the first national level medical hi-tech zone focusing on bio/med-tech industry. It is a professional medical hi-tech zone with the largest scale and most complete value chain including medicine, medical device, R&D, manufacturing, trading and healthcare services. CMC has good collaboration with several global companies, such as AstraZeneca, Takeda and Boehringer-Ingelheim. Approved by the CFDA, a member of co-built Ministries the CMC, Jiangsu Provincial CFDA has set up the only one branch office in the CMC which could perform the provincial CFDA function. JSFDA CMC branch could make a point-to-point application fast track /green channel to central CFDA and provide consultation and acceptance of application of the provincial level for CMC companies. In addition, Institute for Drug Control and Medical Device Testing Institute have been set up in the CMC, which greatly shorten the time for products to get inspection and registration approval. CMC has initiated the CMC - UK Incubator together with Beyond Laboratory, which will provide physical lab space, CFDA assessment services and China-Ready business training to help UK companies to land in China.
